- Did you marry an Oklahoma resident? If so, we need a copy of your marriage license and supporting documentation that your spouse is an Oklahoma resident (last two years taxes, employment verification, etc.)
- If you are a foreign-born US citizen, proof of citizenship (birth certificate or copy of passport).
- A copy of yours or your spouse's Military Leave Earning Statement showing Oklahoma as your tax state.
