Eligibility Requirements:

- * Must have a 2025-2026 FAFSA on file.
- * NOTE: The amount of loans you received Fall 25/Spring 26 will affect your loan eligibility for the Summer 2026 term.
- * Must be registered for at least six (6) hours for Undergraduate students or five (5) hours for Graduate students for the Summer term to receive Federal Loans. All courses must be required for your degree program. ECU does NOT fund for certificate programs.

*PELL grants cannot be finalized until after Census date (June 5th). All credits, including internship credits, must be in place by this deadline to be counted towards determining final Pell Grant amount for the summer term.

Students who wish to borrow subsidized/unsubsidized loan for the Summer session must have remaining loan eligibility for the 2025-2026 year, or they must be advancing from Freshman to Sophomore or Sophomore to Junior status at the end of the Spring term.
