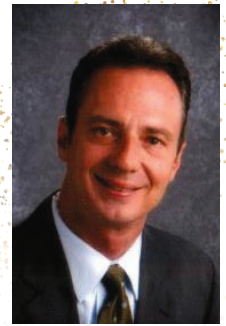

RUBEN ELIZARDE – 1970 ALUM

Although Ruben Elizarde is referring to his own experiences, he may as well be talking to the next generation of Tigers. It's fitting wisdom from a career teacher and coach who is now a member of East Central University's most prestigious circle. Elizarde (1970) has been named an ECU Distinguished Alumnus for 2020. He promptly dedicated the honor to his parents. "You look back and you think of the reasons why you did the things that you did," he said. "I can't help but think about my mom and dad. Our parents are our first teachers."

As ECU's first-ever Hispanic student-athlete in 1966, Elizarde is no stranger to overcoming obstacles. It started long before he arrived in Ada, Oklahoma. Growing up in Harlingen, Texas—about as far south in the state as you can go—Elizarde started elementary school without knowing how to speaking English. Overcome with nerves, he asked to stay home. "Solo di por favor y gracias," his mother told him on that first day. "Just say please and thank you." Her gentle reassurance would spark a lifetime of achievement.

"If you have a hunger in your heart and you want to feed it, go out and do the things to accomplish that," Elizarde said. "Everyone wants to be successful, but along the way it's not going to be easy. Because if it was easy, everybody would be successful. It's the people that get knocked down and get up and keep trudging ahead, they learn that they've got to make sacrifices."

ECU Football turned out to be Elizarde's early vehicle for success. Not the largest player on the team, his determination and hard work led to a successful playing career with the Tigers and in his life beyond. Before he graduated in 1970, Elizarde was twice named All-Conference middle linebacker on teams led by legendary coach Elvan George, who he cites as a mentor along with coach Pat O'Neal. Not bad for a young man whose arrival at ECU also marked his first trip north of the Red River.

"There was an East Central University family back then, just as there is now," Elizarde recalled. "Coaches, professors, people in administration – it was a very close-knit family. When the opportunity arose to become a coach and teacher after graduation, I was ready and I found all the tools I needed at East Central University, which gave me the means to provide for my family and be successful in my career."

Elizarde indeed enjoyed great success throughout his life. After graduating from ECU, he started a coaching career that spanned more than five decades – including collegiate work at Baylor University, Colorado State University-Pueblo and Midwestern State University.

Elizarde also coached four large Texas high schools, compiling a winning record across that span. He helped three of those schools to state playoff appearances and was named Texas Coach of the Year on four occasions.

In 2007, Elizarde left Texas for McAlester, Oklahoma, to stay. He did some coaching there as well, but primarily he settled into a busy retirement with the greatest gift ECU gave him – his wife Karla, who also graduated as a Tiger in 1970. The couple have been married for 50 years and have two successful sons and several grandchildren.

In 2016, Elizarde received ECU's Milam Award, which goes to a former Tiger football player who not only excelled in the classroom and on the gridiron, but also distinguished himself in his chosen career. The award is named in honor of Joe Milam, a former educator and coach in the states of Oklahoma and Texas. With that prestigious honor, Elizarde believed he had reached the pinnacle of achievement at ECU. Four years later, the call came from President Katricia Pierson announcing his Distinguished Alumnus award.

"I was shocked, I was overwhelmed," Elizarde said. "I am

very proud, but at the same time very humbled by it, because there's been so many great people before me. I really appreciate all the people who were involved with me being selected for this award. It has made my career and the sacrifices that I have put in all worthwhile."

Elizarde was so fond of his time and experience at ECU that he established the Ruben and Karla Elizarde Centennial Athletic Endowment. The scholarship is awarded to a student-athlete of Hispanic heritage – male or female – who has completed athletic eligibility, but still needs additional hours to obtain a bachelor's or master's degree. He also actively donates to the ECU Alumni Association, the Excellence in Women's Athletics Campaign, the Varsity Club and the Tiger Club. "I want to give to ECU, because it was given to me," Elizarde said.

Ever the teacher, Elizarde offered one parting piece of advice to present and future Tigers. "Get to know the adults around you," he said. "Be respectful and listen to them, because one of them is going to have that spark that's going to light that fire inside of you and make you achieve. I was lucky enough to have that when I was at ECU. Once a Tiger, always a Tiger!"



"Hit 'em in the numbers!"

DR. ED HUCKEBY – 1970 ALUM



"The Flames of Friendship once kindled and nurtured flicker in the winds of death yet burn on undaunted by time and space shining through the night as the light of a distant star."

These inspirational words are from the poem "Of A Distant Star" written by Dr. Ed Huckeby, who also composed a moving piece of music with same title. As described in the liner notes of a recording of this particular piece, Huckeby is "an eclectic composer with a broad creative streak...noted for his exciting style of composition which features abundant use of mixed meters, dynamic scoring and memorable melodies." More succinctly, Huckeby (1970) is one of the most respected band composers living today - his sparkling career leading to an ECU Distinguished Alumnus Award for 2020.

"I am deeply honored to be recognized as a 2020

ECU Distinguished Alumnus, especially since that recognition comes on the 50th anniversary of my graduation from East Central University," Huckeby said. "It is incredibly humbling to be among those honorees from the past who have had such a meaningful impact on the university throughout their distinguished Careers."

Broadly creative, Huckeby is an arts consultant and freelance composer, arranger, conductor, and clinician. His career has included roles in higher educations and arts administration, most recently serving as president of Southwestern Christian University in Bethany, Oklahoma, until his retirement in 2014.

Prior to his appointment at SCU, Huckeby was chief academic/operating officer and professor of Music for over a decade at Northeastern State University-Broken Arrow. He also served as an arts administrator for Tulsa Ballet Theatre and holds the title of emeritus professor of Music at Northwestern department chair and dean of the graduate school.

"I owe a tremendous debt of gratitude to the faculty who were at East Central during my formative years from 1966 to 1970, especially professor Don Gant, director of bands, who served as a model for perseverance in my composing and arranging career, through his tireless efforts as a 'one-man' instrumental music department," Huckeby said.

Huckeby directed the Allen, Oklahoma, high school band while he earned his degree from ECU. His early music education career included eight years in Oklahoma public schools, where his marching, concert and jazz bands won state and regional acclaim. Significant success in public schools led him into the college ranks where he became internationally recognized as an outstanding music educator and composer of over 200 published works for concert and marching band.

Huckeby - who would go on to earn higher degrees at the University of Oklahoma and Oklahoma State University - again pointed to his experiences at ECU. "My concept of music appreciation was formed in DR. Robert Kaebnick's 'Music in Life' class where the classics and an overview of music history were first introduced to me. And it was in professor Charles Tracey's Music Theory classes that I came to realize the gift of music that I had been given, which was nurtured through Mr. Tracey's outstanding instruction in theory, counterpart, music history and 20th century harmonies."

Huckeby's many outstanding contributions to concert and marching band literature have played an important role in the development of the contemporary band repertoire, and his recently released sight-reading and music literacy curriculum, published by the C.L. Barnhouse CO., is receiving world-wide acclaim. As passionate about writing as he is composing, Huckleby has written music education articles for *The Instrumentalist*, *The American*

Music Teacher, and *The Journal of the International Horn Society*.

Often recognized by his peers, Huckleby's memberships include the Music Educators National Conference, Oklahoma Music Educators Association, Oklahoma Bandmasters Association, ASCAP, Phi Mu Alpha Sinfonia and Phi Beta Mu, where he served as a member of the national board of directors and state chapter president.

Huckeby's career is dotted with high notes, having been selected as an "Outstanding Young Man in America," named to the "International Who's Who in Music," and inducted into the Oklahoma Bandmasters Association Hall of Fame in 1996. He has created more than 50 commissioned works and has served as a clinician, adjudicator and conductor for instrumental ensembles around the world, including Japan, Australia, Canada and across the United States. Huckleby and his wife Latricia, now live in Broken Arrow, Oklahoma, near their daughters,

Angela and Amanda, and their six grandchildren.

"Although my life ambition when at East Central was to become an assistant band director in a small college, I soon learned that goal-setting, perseverance and adaptability are essential elements in building a career," Huckleby said. "Upon reaching each new career level, I was able to re-assess, set new goals and adapt to new challenges. I attribute that attitude of flexibility and determination to the outstanding educational foundations I received at East Central University. ECU will always be my home in the world of higher education."

TYPES OF GIFTS

GIFTS OF CASH, CHECK, OR CREDIT CARD

These gifts are always welcome because they are available immediately to strengthen the Foundation and the University or begin earning income for the future.

GIFTS OF PERSONAL PROPERTY

Personal property can include coin collections, antique cars, gun collections, artwork, musical instruments, etc.

GIFTS OF REAL PROPERTY

Real estate, homes, business property and farmland that have grown in value can result in capital gains taxes if sold, or tax advantages are available through a charitable gift to the Foundation. When the Foundation acquires your gift of appreciated stock or property, you receive a tax deduction equal to its fair market value and also avoid costly capital gains tax on the increase in value.

GIFTS IN-KIND

Donations of software, licenses, services, vendor products, and other property also support the mission and programs of ECU. These gifts in-kind allow the Foundation to use our resources for other needs while you get credit for your support.

GIFTS OF SECURITIES

These gifts include stocks, bonds, mutual funds and IRAs. These are available immediately to impact the work of the Foundation.

GIFTS OF TRUST

This can include charitable remainder trusts, unitrusts, lead trusts, family trusts, annuity trusts, etc., that can avoid capital gains taxes and provide an annual income for life.

GIFTS OF INSURANCE

Naming the Foundation as the owner and beneficiary of your life insurance policy is also an option, especially when your policy has a face amount that is much greater than the amount you could afford to give in cash. By assigning ownership to the Foundation and making the Foundation the beneficiary of an old policy that is no longer needed for its original purpose, such as sheltering children's education, you can make a substantial gift at a low cost and take an immediate income tax deduction for the cash value of the policy. You can then contribute an amount equal to the policy's premiums to the Foundation and deduct that gift as a charitable contribution. Proceeds of the policy will pass to the Foundation free of estate taxes. New policies may also be obtained listing the Foundation as the owner and/or beneficiary as a part of financial or estate planning.

WILLS & LIVING TRUSTS

The will is the most widely used estate-planning tool in America today. A simple document that is easily drafted and updated, it remains the most popular method of planned giving, for almost every charity, including the ECU Foundation. There are five types of charitable bequests you can make when directing all or part of your estate to the Foundation:

General Bequest: an agreed-upon dollar amount.

Specific Bequest: a specific, identified property or security, including real estate, stocks, or bonds.

Residuary Bequest: all or a portion of an estate's property after all debts, taxes, expenses and other bequests have been made.

Contingent Bequest: the Foundation serves as an alternate beneficiary in case a beneficiary dies or disclaims a bequest.

Restricted Bequest: any of the above bequests with a specific purpose for the property, such as establishing a scholarship or endowment.

While a will can be a simple and effective option for many, a living trust might allow assets to be distributed to heirs without the delays or costs of probate. Be sure to consult with a qualified professional before you draft your will or trust and review it often.
