### Apply for Scholarships

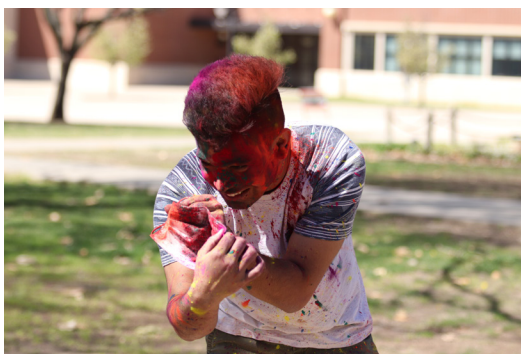
Priority scholarship application deadline is Feb. 1 for the next academic year. To qualify, you must be a current student.
