Some of you I have had the pleasure of working with, and some of you I am excited to meet! I wanted to give you a quick update on what I have been up to over the past 1.5 years—lots and lots of training! I have completed training in the Pyramid Model (Infant/Toddler, Birth-Five, and Preschool), Conscious Discipline (regular and currently working on completing the Infant Toddler version), and watched a plethora of webinars about trauma, social-emotional development, and brain development. I have enjoyed gaining all this knowledge, but I am looking forward to getting back into classrooms now that we have the green light!

Our Infant Toddler Program is a quite a bit different than before. As of now, my role will be more like Georgiana's no commitment to have me working with your teachers for 30 hours! I am available do TA and/or I can coach teachers who have gone through the Pyramid Model Training. Has your center completed the **Pyramid Model Training**? If not, I highly recommend it! To sum it up in one sentence, "The Pyramid Model is a conceptual framework of evidence-based practices for promoting young children's healthy social and emotional development" (NCPMI).

If you would like more information on the Pyramid Model or are interested in being trained—either online or in person please let me know.

If your center has been trained, I am available to come in and coach your Infant Toddler teachers on specific practices they want to work on. I am also available to help your Infant Toddler teachers with routines, lesson/activity planning, promoting language development, social-emotional development, schedules, room arrangement, etc.

JULY-SEPTEMBER TRAINING OPPORTUNITIES Most are FREE or have only a small registration fee.

You must pre-register for all training at www.okregistry.org. Please register early to prevent the class from being cancelled for low registration numbers. We have had to cancel several trainings because of lack of participation. Participants will be notified if the class is cancelled for any reason.

Safe Sleep Training

Several Self-Paced Web Based courses are available to meet the Oklahoma Child Care Services-Licensing requirement for safe sleep training. See the CECPD website for a full list of options and descriptions. The link to register may be found at <u>www.okregistry.org</u>.

ELG Training

Two Self-Paced Web Based ELG trainings are being offered by CECPD. Both are fourteen hour courses and the cost is \$20 for each. From the desk of Brittany Lee, Director of Child Care Services

Dear Child Care Program or Agency;

As you are aware, the Office of Background Investigations (OBI) currently has a backlog and are processing requests received mid-June. We acknowledge completed background investigations are not being received in the expected amount of time. To fully support programs we wanted to remind you that an individual with a Preliminary background notification may work or be present in the program as long as that individual is under supervision of an approved personnel or caregiver in the same building or home with completed background results. Verification of the completed submission request and fingerprint submission must be maintained on site.

340:110-3-282. Background investigations

(a) **General.** Background investigation requirements are met.

(1) Required individuals. Background investigations are required, per Section 401 et seq. of Title 10 of the Oklahoma Statutes (10 O.S. §§ 401 et seq.), Oklahoma Child Care Facilities Licensing Act (Licensing Act), unless an exception per (3) of This subsection applies for:
(A)owners, prior to authorization to operate:
(B)responsible entities, prior to authorization to operate and, when there is a change in a responsible entity;
(C) personnel applicants, prior to hire. However the program may hire individuals, when:

(i) the program has submitted a criminal history review request to the Office of Background Investigations (OBI);
(ii) only awaiting the national criminal history records search, based on fingerprint submission;

(iii) criminal history review results from OBI are received by the program. However, until complete results are received, the individual does not have unsupervised access to children;

We are very proud of her accomplishment! **The Scholars Program-What is it?** Scholarships are available to eligible child care professionals completing coursework in the area of child development or early childhood education, as well as, the Child Development Associate (CDA) and Certified Childcare Professional (CCP) Credential Assessment. These scholarships are designed to enable child care providers in Oklahoma to improve their skills through education, receive an educational stipend, and continue the availability of quality child care in local communities.

Stipends are available through the Scholars for Excellence in Child Care Program and are valued from \$800-\$1200 for eligible scholars. Credentials can be earned toward CDA, CCP, CoM, SACoC, DCoC, DCom, and Associate Degree or Bachelor's Degrees. More than one stipend may be earned.

OKLAHOMA REGISTRY CERTIFICATE OF ACHIEVEMENT STIPEND PROGRAM

Applications for the Certificate of Achievement Stipend must be submitted by September 30, 2021.

Certificate of Achievement Stipend Training-

1st Certificate of Achievement – Looks back five (5) years for training

2nd through 5th Certificates of Achievement – Looks back 12 months from the application date

Training is specific. Be sure you are taking the right courses. To locate approved trainings for each certificate

- 1) Visit the Statewide Training Calendar at <u>www.okregistry.org</u>
- 2) On the left navigation menu, click on Training Content
- 3) Click on Certificate of Achievement and Stipend
- 4) Choose the Certificate of Achievement you are interested in. Required courses will be listed.

Training hours are counted by minutes. The number of minutes may vary by quantity and complexity of the lesson content. Students will not be able to mark a lesson complete until the required time period has lapsed. This is shown on the countdown calendar button on each lesson page. If you complete a lesson before the time is lapsed you should stay on the lesson page until it has done so. Navigating away will reset the timer and you will be forced to wait longer. Use the extra time to read or review any downloaded materials. Time-in-training requirements are designed to support the educational quality of online courses.
