- ( ) 122 credit hours required for a B.S. Degree (60hrs @ a 4-yr institution; 40hrs @ JR or SR (3000-4000) level courses; 30hrs @ ECU (15 of the last 30hrs must be at ECU). General education requirements must be met prior to graduation
- ( ) A minimum retention/grad grade point average (GPA) and program GPA of 2.70/4.0 in all course work completed at the time of application, unless reviewed & approved on a case-by-case basis by Director and a committee of faculty members
- ( ) A minimum of 24 hours of Gen Eds/Required Related Work/Support Courses, or the equivalent thereof, must be completed at the time of the application, unless reviewed & approved on a case-by-case basis by Director and a committee of faculty members
- ( ) BIOL 2184 Human Anatomy or its equivalent must be completed & passed with a grade of “C” or higher prior to enrollment of the first semester nursing courses, unless reviewed & approved on a case-by-case basis by the Director and a committee of faculty members
- ( ) Nursing Required Related Work/Support Courses (as noted on Degree Check & Unofficial Academic Plan) must be completed prior to the second semester nursing courses, unless reviewed & approved on a case-by-case basis by Director and a committee of faculty members
- ( ) Required Gen Eds & all Required Related Work/Support Courses (as noted on Degree Check & Unofficial Academic Plan) require a grade of “C” or higher to be considered passing for the nursing program
- ( ) Meet with your advisor prior to enrollment each semester & before deviating from any previously discussed planned courses
- ( ) The application scoring rubric is not published and is based on points that may include, but is not limited to: GPA (program & ret/grad), area college hours, entrance exam scores, and math & science course grades, & prior experience
- ( ) Nursing majors on the ECU Ada campus and all students in the nursing program have access to all campus resources (financial aid, health services, counseling, etc.)
- ( ) Knowledge of requirements for the program is your responsibility. If, at any point after admission to the School of Nursing, it is determined you have not completed all requirements and/or prerequisite courses, you may be administratively removed. You are responsible for any consequences that occur when deviating from the program requirements and your advisor’s recommendation
- ( ) Monitor [www.ecok.edu/nursing](http://www.ecok.edu/nursing) nursing for deadlines, entrance exam dates, updated application material, and other information regarding the nursing program
- ( ) All applicants will have to affirm if they DO or DO NOT have a criminal record/history. If an applicant has a criminal record/history, they must speak to the Director of the School of Nursing prior to submitting their application. A detailed background and Sex Offenders Registry search are required prior to beginning the first semester of the program and before licensure exam; drug screening also required
